## **WRIG Welcomes New Chair**

Wheatley River watershed resident, Dr. James Kemp, UPEI Research Biologist and Associate Professor, has been involved in research relating to pollination and floral morphology. He initiated and co-led a project involving wild roses as an alternative crop for bioactive compounds in Atlantic Canada. His work also involves pesticides and the decline of honey bees in Atlantic Canada. His general research expertise is in the field of pollination biology and floral morphology



of native species of plants. Recently, his work has focused on blueberry pollination, and the sustainability of native pollinators. Dr. Kemp has also developed a collaborative research program examining the development of native rose species as a major source of bioactive substances. Dr. Kemp has sat on the PEI Environmental Advisory Committee and worked with other groups concerned with provincial environmental health.

The use of native plants to improve wildlife habitat, beautify yards and reduce the size of lawns is attracting increasing attention across the country. Renowned expert Gary Schneider, of the MacPhail Woods Ecological Forestry Project, will lead these workshops. Participants will learn about what types of plants provide the best food, both for wildlife and humans, and get a chance to discuss some of their own landscaping situations.

## **WRIG Coordinator's Report**

At WRIG's 2010 AGM on Thursday Feb.18, our report documented a super-busy year. We should all be proud that besides the careful development of a solid plan for our first major flagship project, i.e. Phase 1 of the Restoration of Rackham's Community Pond, we also held numerous fundraisers, provided environmental awareness activities at the pond and in schools, held our second "*Day on Our River Festival*", facilitated a World Water Day event with Hunter Clyde watershed, provided stream site assessments to local landowners and the labour to make environmental improvements. Our summer field crew accomplished a sizable amount of in-stream restoration, planted 555 trees, installed sections of brush-mats, removed a mountain of garbage from portions of streams and revitalized our tree nursery at Crooked Creek Farm. They also restored a good section of walking trail along a beautiful and unique stretch of river, just off the Little Bungay Road.

We organized free workshops, participated in Provincial and regional watershed group planning and consulted the community about planning for the revitalization of Wheatley River Hall. Should this endeavour be successful, and sufficient funding secured for a major renovation, the building will be greener, better equipped and vastly more energy efficient. Its usage will broaden to become a multi functional community space and a site dedicated to preserving the natural and cultural history of the Wheatley River Watershed. An energy audit was scheduled in late March, bringing the group a step further along the application process.

Last fall, WRIG, worked in conjunction with the Federation of Agriculture to organize an afternoon W.R. Watershed Farm tour, where we got to highlight some of our local producers who have environmental farm plans and are using agricultural best management practices, others who are considered pioneer organic growers and still others who have recently achieved "certified" organic status.

As the winter wears thin, WRIG continues to plan for and provide opportunities for our watershed residents that result in a positive outcome such as improved local water quality, increased bio- diversity, and greater understanding of our own human impact on the watershed. We invite you to participate in all our activities and meetings and hope you will offer suggestions for specific events you would like to see in our communities.

The AGM saw the fulfilling of terms by some of our dedicated founding directors as well as the welcome addition of several new ones. We owe serious thanks to retiring Board members Pierre-Yves Daoust, Melvin Ling and Lloyd and Lynn Ross for all they have contributed over the years. And we welcome the new and returning Board members listed below.

It's been a great year, one full of challenges and successes, and it is with the support of our watershed community, our government and our dedicated directors and membership that this good environmental work will continue in our Wheatley River Watershed for another year.

## **Rackham's Pond Angling Restrictions. Opening Delayed to May 24th Family Fishing Weekend.**

We know that local anglers can't wait for the opening of the season and the new Rackham's Pond will play a role in this spring ritual but a little later. We are excited to have people visit and enjoy the area but a delayed opening is necessary to give the new grass and vegetation time to establish and further stabilize the banks. This will avoid the possibility of sections of the bank breaking away and sliding back into the basin. The delay will ensure that the fragile banks remain safe and solid. Signs outlining the conservation restrictions will be posted before April 15th, and notices of the same will be placed in newspapers. Proudly, the Rackham's Community Pond basin has been identified as the only wildlife conservation area in the Wheatley River Watershed. After May 24, anglers wishing to use barbless hooks and adhere to the reduced daily catch limit of 5 fish will be welcome to be among the first to enjoy fishing at the new Rackham's Pond. What's good for the fish is good for the angler. Thank you for respecting our pond.

**Qualifications:** At least one year post-secondary education, preferably in the area of environmental sciences, biology, forestry, conservation or wildlife management. If you have been a full-time student in 2009 and returning to school in the fall of 2010, have a valid driver's license and daily access to a vehicle, contact us. Must be between the ages of 18 and 30, and have demonstrated the capacity to work independently.

**Duties:** Plan and oversee summer field project for WRIG, including remedial stream work, planting trees, water quality monitoring and maintaining a tree nursery. The position also includes communicating with the public, writing reports and newsletter articles and helping to organize a community event.

The Field Supervisor is responsible for 2-3 crew members and at times for larger crews of students. The Field Supervisor will report to the WRIG Coordinator & Board of Directors of the Wheatley River Improvement Group.
